CONFIRMATORY TRADEMARK ASSIGNMENT

This CONFIRMATORY TRADEMARK ASSIGNMENT (*Assignment*) is effective as of December 31, 2014 (the *Effective Date*), by and between Invensys Systems, Inc., a Massachusetts corporation with a business address of 38 Neponset Avenue, Foxboro, Massachusetts 02035 (*Assignor*) and Schneider Electric Software, LLC, a Delaware limited liability company with a business address of 26561 Rancho Parkway South, Lake Forest, CA 92630 (*Assignee*).

RECITALS:

WHEREAS, Assignor is the registered owner of the trademark applications and registrations identified on Schedule A to this Assignment (the *Trademarks*);

WHEREAS, pursuant to that certain Global Solution Industry Software Business Contribution Agreement dated December 31, 2014 by and between Assignor and Assignee (the *Contribution Agreement*), Assignor assigned the Trademarks to Assignee.

NOW, THEREFORE, in consideration of the promises and covenants set forth herein and in the Contribution Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor contributed, transferred, conveyed and assigned to Assignee, among other assets, Assignor's entire right, title and interest in and to the Trademarks, together with the goodwill symbolized thereby, including the right to sue for all past, present and future infringement and dilution thereof and to settle and retain proceeds from any such actions. Any Trademark applications were assigned as part of the entire business or portion thereof to which the mark pertains, as required by Section 10 of the Trademark Act, 15 U.S.C. §1060.
2. Cooperation. This Assignment has been executed and delivered by Assignor for the purpose of recording the assignment herein with the appropriate government entity. Assignor agrees to execute and deliver to Assignee, at Assignee's sole cost and expense, such further assignments and related documents with respect to the Trademarks, as Assignee shall reasonably request to vest the title to the Trademarks in the name of the Assignee.
3. General Provisions. Capitalized terms used herein but not defined herein shall have the meanings set forth in the Contribution Agreement. This Assignment along with its Schedule, together with the Contribution Agreement, constitute the entire understanding and agreement of the parties hereto with respect to the subject matter hereof and supersede all prior and contemporaneous agreements or understandings, inducements or conditions, express or implied, written or oral, between and among the parties with respect hereto. In the event of any conflict between the terms of this Assignment and the terms of the Contribution Agreement, the terms of the Contribution Agreement shall control. This Assignment may not be supplemented, altered, or modified in any manner except in writing signed by all parties hereto. The failure of any party to enforce any terms or provisions of this Assignment shall not waive any of its rights under such terms or provisions.

4. Governing Law. This Assignment shall be governed by, and construed in accordance with, the Laws of the State of New York, without regard to any conflict of laws provisions thereof that would result in the application of the laws of another jurisdiction.

5. Counterparts. This Assignment may be executed in counterparts, each of which will be an original as regards any party whose signature appears thereon and both of which together will constitute one and the same instrument.

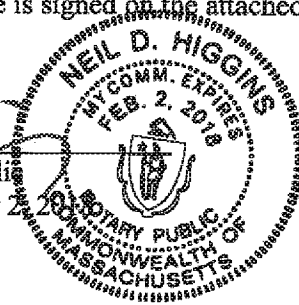
