TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of December 29, 2016, by WELLS FARGO BANK, NATIONAL ASSOCIATION (successor by merger to Wachovia Bank, National Association, successor by merger to Congress Financial Corporation) and WELLS FARGO CAPITAL FINANCE CORPORATION CANADA (successor to Wachovia Capital Finance Corporation (Canada), successor to Congress Financial Corporation (Canada)), (individually the "Secured Party" and collectively the "Secured Parties").

WHEREAS, pursuant to the terms of the Trademark Security Agreement (as amended, modified, extended or restated from time to time, the "Agreement"), dated May 2, 2003 between NOVOCOL, INC. (the "Debtor") and the Secured Parties, the Debtor granted to the Secured Parties a security interest in and lien on the trademarks identified on Exhibit A attached hereto (collectively, the "Trademarks"); and

WHEREAS, the Agreement was recorded with the United States Patent and Trademark Office on May 13, 2003, at Reel 002731 and Frame 0907; and

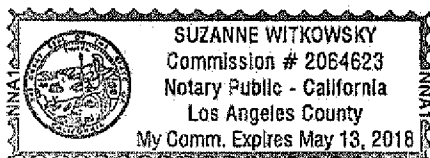
