**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE dated as of November 22, 2016 (this "Release") is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, acting in its capacity as administrative agent (in such capacity, the "Agent") under that certain Trademark Security Agreement, dated as of May 19, 2015 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among RSI INSURANCE BROKERS, INC., a California corporation (the "Debtor") and the Agent. Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on May 20, 2015 at Reel 5520, Frame 0553, the Debtor granted to the Agent a continuing security interest in all of the Debtor's right, title and interest in, to and under its owned or thereafter acquired Trademarks, including, but not limited to, those set forth on the attached Schedule A (the "Trademark Collateral");

WHEREAS, the Debtor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) discharge and release its security interest in the Released Collateral, and (c) reassign any and all rights, title and interest it has in the Released Collateral to the Debtor. The Agent agrees to make filings with the United States Patent and Trademark Office and take further actions, in each case as reasonably requested by the Debtor and at the sole expense of the Debtor, to evidence the release and termination of the Agent's security interests in the Released Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE DEBTOR'S AND THE AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
