TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of December 30, 2016 (the "Effective Date"), by and between Ameriform Acquisition Company, LLC, a Michigan limited liability company d/b/a KL Outdoor LLC ("KLO Michigan") and Ameriform Acquisition Company, LLC, a Florida limited liability company ("KLO Florida"), on the one hand, and KLO Acquisition, LLC, a Delaware limited liability company ("Assignee"), on the other hand. Each Assignor and Assignee are referred to herein individually as a "Party" and collectively as the "Parties." Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in the Purchase Agreement (as defined below).

**WHEREAS**, KLO Michigan and Assignee are parties to that certain Asset Purchase Agreement of even date herewith (the "Purchase Agreement");

**WHEREAS**, in connection with the Purchase Agreement, Assignors have agreed to assign to Assignee the following (collectively, the "Marks"): all of each Assignor's respective right, title and interest in, to and under all corporate names, tradenames, trademarks, service marks, logos, trade dress, slogans, and other indicia of origin and all applications and registrations with respect to any of the foregoing and the goodwill connected with the use of and symbolized by any of the foregoing, including the trademarks set forth on Schedule 1 attached hereto; and

**NOW, THEREFORE**, in consideration of the agreements set forth in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Parties hereby agree as follows:

1. Each Assignor hereby sells, assigns, transfers, conveys and delivers to Assignee, and Assignee hereby purchases from such Assignor, free and clear of all Encumbrances other than Permitted Encumbrances, all of such Assignor's right, title and interest in, to and under the Marks, including all income, royalties, damages and payments accrued, due or payable as of, prior to, or after the Effective Date (including damages and payments for past, present or future infringements, misappropriations, dilutions, or violations thereof), the right to sue for past, present and future infringements, misappropriations, dilutions, or other violations thereof, and any and all corresponding rights that, now or hereafter, may be secured throughout the world.

2. Each Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks, and the corresponding entity or agency in any applicable foreign country, to record Assignee as the owner of the Marks identified on Schedule 1.

3. KLO Michigan acknowledges and agrees that it is subject to the obligation to provide, and KLO Florida agrees to provide, further assurances as if they were Sellers under the Purchase Agreement pursuant to Section 6.9 of the Purchase Agreement, which is incorporated herein by reference.

**EXECUTION COPY**

4. Each Assignor and Assignee acknowledge and agree that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement will not be superseded hereby but will remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern. All notices and other communications hereunder shall be as set forth in the Purchase Agreement.

5. This Assignment shall be governed by and construed in accordance with the internal laws of the State of Michigan without giving effect to any choice or conflict of law provision or rule (whether of the State of Michigan or any other jurisdiction).


6. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.
