RELEASE OF SECURITY INTEREST

This **RELEASE OF SECURITY INTEREST** (this "Release") is made as of January 19, 2017 ("Effective Date"), by **SILICON VALLEY BANK**, a California corporation ("Bank"), in favor of **BUILDUM, LLC**, a Delaware limited liability company ("Grantor").

WHEREAS, reference is made to that certain Loan and Security Agreement, dated as of February 6, 2015 (as the same may be amended, modified, or supplemented from time to time), by and between Bank and Grantor;

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement, dated as of February 6, 2015 (as the same may be amended, modified, or supplemented from time to time, the "Security Agreement"), by and among Bank and Grantor, Grantor granted, assigned, and pledged to Bank a continuing security interest in all of Grantors' right, title and interest in and to the Intellectual Property Collateral (as such term is defined in the Security Agreement) (the "Intellectual Property Collateral");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on February 6, 2015 at Reel 5454, Frame 0982;

WHEREAS, Bank now desires to release its security interest in the Intellectual Property Collateral, including, but not limited to, the trademark registrations listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby covenants and agrees as follows:



Without representation or warranty of any kind or nature, Bank hereby terminates, releases, and discharges its continuing security interest in the Intellectual Property Collateral granted, assigned, and pledged pursuant to the Security Agreement, and reassigns to Grantor all right, title, and interest of Bank in the Intellectual Property Collateral pursuant to the Security Agreement.

2. Bank hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantor's expense, as may be reasonably necessary to effect the release of the security interest in the Intellectual Property Collateral contemplated hereby.
