GRANT OF SECURITY INTEREST


FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Mission Broadcasting, Inc., a Delaware corporation (the “Grantor”) with principal offices at 30400 Detroit Road, Suite 304, Westlake, OH 44145-1855, hereby assigns and grants to Bank of America, N.A., as Collateral Agent, having an office at 222 Broadway, 14th Fl, Mail Code: NY3-222-14-03, New York, New York 10038 (the “Grantee”), a security interest in (i) all of the Grantor's right, title and interest in and to the United States trademarks, service marks, trademark registrations and trademark applications (the “Marks”) set forth on Schedule A attached hereto, (ii) all of the Grantor's right, title and interest in and to the United States patents (the “Patents”) set forth on Schedule B attached hereto, (iii) the goodwill of the businesses with which the Marks are associated, (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and Patents or unfair competition regarding the same and (v) all Proceeds (as such term is defined in the Guarantee and Security Agreement referred to below) and products of any and all of the foregoing. Notwithstanding the foregoing, no security interest is granted or assigned in any trademark application filed on an intent-to-use basis until such time, if any, as a Statement of Use or Amendment to Allege Use has been filed and accepted in the United States Patent and Trademark Office.

THIS GRANT OF SECURITY INTEREST is made to secure the satisfactory performance and payment of all the Secured Obligations, as such term is defined in the Credit Agreement dated as of January 17, 2017 by and among Mission Broadcasting, Inc., the lenders party thereto and the Collateral Agent. Upon the occurrence of the Lien Termination Date (as defined in Section 12.11(b) of the Guarantee and Security Agreement among the Grantor, the Grantee and the other parties thereto, dated as of January 17, 2017 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “Guarantee and Security Agreement”), the Grantee shall, upon such satisfaction, execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Marks and Patents acquired under this Grant of Security Interest at Grantor’s expense.

This Grant of Security Interest has been executed and delivered in conjunction with the security interest granted to the Grantee under the Guarantee and Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Guarantee and Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant of Security Interest are deemed to conflict with the Guarantee and Security Agreement, the provisions of the Guarantee and Security Agreement shall govern.
