ASSIGNMENT

This Assignment (this "*Assignment*") is made and entered into this 19 day of January 2017, by and between Missouri Bank and Trust Company of Kansas City, a Missouri corporation (Missouri state banking association), having an address of 1044 Main Street, Kansas City, MO 64105 ("*Assignor*") and BOK Financial Corporation, an Oklahoma corporation, with a business address at Bank of Oklahoma Tower, P.O. Box 2300, Tulsa, OK 74192 ("*Assignee*").

WHEREAS Assignor is the owner of the trademarks, service marks, tradenames and registrations thereof set forth on Schedule A attached hereto (the "*Marks*"), and the goodwill associated therewith;

WHEREAS, MBT Bancshares, Inc., parent company of Assignor, and Assignee entered into a Stock Purchase Agreement dated December 8, 2015, closing effective as of December 1, 2016, wherein Assignee purchased all of the stock of MBT Bancshares, Inc. and indirectly, all ownership rights in Assignor;

WHEREAS, Assignor, now a wholly owned subsidiary of Assignee, and Assignee desire to assign the Marks to Assignee.

NOW, THEREFORE, for \$10.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, sells and sets over unto Assignee all of Assignor's right, title and interest in and to the Marks, together with any common law rights and all of the goodwill of the business symbolized therewith, including all rights therein provided by international conventions and treaties, as well as the right (but not the obligation) to assert the Marks and to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past and future acts of infringement that have occurred or may occur, as fully and effectually as they would have been held by Assignor had this Assignment not been made.
2. Assignor shall, at Assignee's expense but for no additional cost, take all actions and execute all documents necessary or desirable to record and perfect the interest of Assignee in and to the Marks, and shall not enter into any agreement in conflict with this Assignment.
3. This Assignment shall be governed by and construed in accordance with the laws of the State of Oklahoma (regardless of the laws that might otherwise govern under applicable Oklahoma conflict of law principles).
