TRADEMARK ASSIGNMENT

This Trademark Assignment (“**Trademark Assignment**”) is entered into as of January 2, 2015 (the “**Effective Date**”) by and between CHG Hospital Beds Inc., an Ontario corporation (as “**Assignor**”), and Stryker Corporation, a Michigan corporation, having its principal place of business at 2825 Airview Boulevard, Kalamazoo MI 49002, United States of America (as “**Assignee**” or “**Stryker**”). This Trademark Assignment is made pursuant to an Asset Purchase Agreement by and among Assignor, Assignee and the other parties thereto, dated as of the date hereof (together with any amendments thereto, the “**Purchase Agreement**”), pursuant to which Stryker and certain of its Affiliates have agreed to purchase the Assets from Assignee. Capitalized terms used herein but not otherwise defined in this Trademark Assignment shall have the meanings ascribed to them in the Purchase Agreement.

Assignor is the owner of certain Intellectual Property. For good and valuable consideration provided in connection with the sale and purchase of assets pursuant to the Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns, its entire right, title and interest in and to the Trademarks owned by Assignor covering, describing, incorporated in, used, held for use by, necessary for the use of or relating to the Business and associated instruments and methods, including but not limited to those listed in Exhibit A hereto (collectively, and including all foreign counterparts, the “**Trademark Rights**”) together with the goodwill associated therewith and the business associated therewith as detailed in the Purchase Agreement. Assignor further assigns to Assignee, its successors and assigns, the entire right, title and interest in and to all claims for damages by reason of past infringement of any Trademark Rights, together with the right to sue for, collect and retain the proceeds for any past, present and future infringement of any such Trademark Rights.

Assignee hereby authorizes and requests the U.S. Patent and Trademark Office and counterpart offices in countries other than the U.S. to issue future Trademarks granted on any Trademark applications listed in Exhibit A hereto to Assignee.

Notwithstanding anything contained herein to the contrary, nothing in this Trademark Assignment shall go beyond, extend, replace, supersede, limit, qualify, void, or exempt any provisions of the Purchase Agreement. To the extent that there is any actual or perceived conflict between this Trademark Assignment and the Purchase Agreement, the Purchase Agreement shall prevail and control.

Without limiting the rights of any party to the Purchase Agreement set forth therein, this Trademark Assignment shall be binding upon and inure solely to the benefit of the parties hereto and their respective successors and assigns and nothing herein, express or implied, is intended to or shall confer upon any other Person any legal or equitable right, benefit or remedy of any nature whatsoever under or by reason of this Trademark Assignment.




