RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on August 11, 2014 at Reel 005340 and Frame 0898; and


WHEREAS, the Lender wishes to release its security interest in the foregoing.
