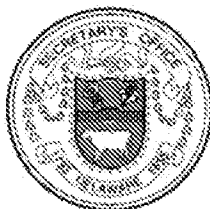

FIRST: The name, jurisdiction of formation or organization and type of entity of each of the constituent entities which is to merge are as follows:

SECOND: An Agreement and Plan of Merger has been approved and executed by (i) NewPage LLC, a Delaware limited liability company (the "Surviving LLC"), and (ii) Verso Paper Holdings LLC, a Delaware limited liability company (the "Non-Surviving Entity").

THIRD: The name of the surviving domestic limited liability company is NewPage LLC.

FOURTH: Pursuant to § 18-209(c)(4) of the Delaware Limited Liability Company Act, the Certificate of Formation of the Surviving LLC, which was filed with the Secretary of State of the State of Delaware on December 7, 2016 (the "Surviving LLC Certificate of Formation"), is hereby amended to change the name of the Surviving LLC from "NewPage LLC" to "Verso Paper Holding LLC". All references in the Surviving LLC Certificate of Formation to "NewPage LLC" are hereby amended to refer to "Verso Paper Holding LLC".

FIFTH: The merger of the Non-Surviving Entity into the Surviving LLC shall be effective on December 20, 2016, at 10:15 a.m. Eastern Time.

SIXTH: The executed Agreement and Plan of Merger is on file at a place of business of the Surviving LLC. The address of such place of business of the Surviving LLC is 6775 Lenox Center Court, Suite 400, Memphis, Tennessee 38115-4436.

SEVENTH: A copy of the Agreement and Plan of Merger will be furnished by the Surviving LLC, on request and without cost, to any member of the Surviving LLC and any member or person holding an interest in the Non-Surviving Entity.
