**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 1, 2017 (this "Termination"), is made by Penfund Partners, Inc., as administrative agent (in such capacity, including any successor thereto, the "Administrative Agent") for the Secured Parties under that certain Second Lien Trademark Security Agreement, dated as of November 20, 2013 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among each of the entities listed on Annex I (and each other person signatory thereto from time to time, collectively, the "Grantors" and each a "Grantor") and the Administrative Agent. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on December 20, 2013 at Reel 5179, Frame 0708, the Grantors granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in all of the Grantors' right, title and interest in, to and under all of its Trademark Collateral, including, without limitation those set forth on the attached Schedule A-1;

WHEREAS, the Obligations secured by the Trademark Collateral have been repaid; and

WHEREAS, the Grantors have requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreements in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in, and the security interest granted to the Administrative Agent in the Released Collateral.
