**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of January 25, 2017 ("Release"), is made by KeyBank National Association ("Bank") in favor of Cole Information Services, Inc., a Nebraska corporation (the "Pledgor").

WHEREAS, pursuant to that certain Credit and Security Agreement dated as of March 6, 2008 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Credit Agreement") by and among the Pledgor and Bank, the Pledgor granted to the Bank a security interest in the all of the Collateral (as defined in the IP Security Agreement), including the foregoing listed on Schedule A attached hereto; and

WHEREAS, pursuant to the Credit Agreement, the Pledgor executed and delivered to the Bank the Intellectual Property Security Agreement recorded at the United States Patent and Trademark Office ("USPTO") on March 20, 2008 at Reel 3744 Frame 0097 ("IP Security Agreement").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank and the Pledgor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Credit Agreement or IP Security Agreement.

SECTION 2. Termination and Release. The Bank without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and continuing security interest in all of the Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Credit Agreement or IP Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at the Pledgor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Ohio.

IN WITNESS WHEREOF, the Bank has caused this Termination and Release of Security Interest in Intellectual Property to be duly executed as of the date first set forth above.
