TRADEMARK SECURITY AGREEMENT dated as of January 25, 2017 (this “Agreement”), between New York Rangers, LLC (the “Borrower”) and JPMorgan Chase Bank, N.A. (“JPMorgan”), as Collateral Agent.

Reference is made to (a) the Credit Agreement dated as of January 25, 2017 (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), among the Borrower, the Lenders from time to time party thereto and JPMorgan, as Agent, and (b) the Security Agreement dated as of January 25, 2017 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”), between the Borrower, as Grantor, and JPMorgan, as Collateral Agent. The Lenders have agreed to extend credit to the Borrower subject to the terms and conditions set forth in the Credit Agreement. The obligations of the Lenders to extend such credit are conditioned upon, among other things, the execution and delivery of this Agreement. Accordingly, the parties hereto agree as follows:

SECTION 1. Terms. Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Credit Agreement or the Security Agreement, as applicable. The rules of construction specified in Section 1.03 of the Credit Agreement also apply to this Agreement, *mutatis mutandis*.

SECTION 2. Grant of Security Interest. As security for the payment or performance, as the case may be, in full of the Secured Obligations, the Grantor pursuant to the Security Agreement did, and hereby does, grant to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all right, title and interest in, to and under (a) the trademarks issued by, and trademark applications filed with, the United States Patent and Trademark Office or any similar offices in any State of the United States, in each case as set forth on Schedule I hereto, including all registrations and applications therefor, and all extensions or renewals thereof, and (b) all goodwill associated therewith or symbolized thereby (collectively, the “Trademark Collateral”).

SECTION 3. Security Agreement. The security interests granted to the Collateral Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Collateral Agent pursuant to the Security Agreement. The Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 4. NHL Requirement. It is acknowledged, understood and agreed that, notwithstanding anything in this document or any other Operative Document to the contrary, (a) the exercise by any Lender of remedies under any Operative Document will be made in accordance with the terms and provisions of the NHL Letter Agreement, the terms, conditions and provisions of which each of the parties to any Operative Document has accepted as reasonable and appropriate, and (b) in the event of

any conflict or inconsistency between the terms of the NHL Letter Agreement and the terms of any Operative Document (including without limitation this document/agreement), the terms of the NHL Letter Agreement will control. All capitalized terms used in this Section and not defined in this Section are defined in that certain letter agreement, dated as of January 25, 2017, by and among the NHL, JPMorgan Chase Bank, N.A., U.S. Bank National Association, The Bank of Nova Scotia, Fifth Third Bank, SunTrust Bank, Wells Fargo Bank, N.A., TD Bank, N.A. and Bank of America, N.A., each as lender, New York Rangers, LLC, and the other parties thereto, as the same may be amended, amended and restated, restated, replaced, supplemented or otherwise modified from time to time (the "NHL Letter Agreement"). For the avoidance of doubt, each party hereto acknowledges and agrees that nothing herein or in any other Operative Document shall give any Club Party an independent right to invoke or enforce any right or remedy set forth in the NHL Letter Agreement.


SECTION 5. Counterparts. This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or other electronic imaging shall be effective as delivery of a manually executed counterpart of this Agreement.
