ASSIGNOR hereby agrees to execute any papers, provide any information and testify in any interference or litigation at the request of ASSIGNEE, its successors, assigns and legal representatives' full enjoyment, protection, enforcement and title in and to such Intellectual Property and rights hereby transferred.

ASSIGNOR furthermore agrees upon request of said ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, to execute any and all papers and to take such other action as reasonably requested or desired by said ASSIGNEE, its successors, assigns and legal representatives, for the filing and granting of Intellectual Property and the perfecting of title thereto in said ASSIGNEE, its successors, assigns and legal representatives. ASSIGNOR further agrees that if ASSIGNOR is unable for any reason to secure the necessary signatures above, then ASSIGNOR hereby irrevocably designates and appoints ASSIGNEE, its successors, assigns and legal representatives, as ASSIGNOR'S agent and attorney-in-fact to act for and on ASSIGNOR'S behalf and to execute and file any necessary documentation and to do all other lawfully permitted acts to further the prosecution, issuance, application, continuation, enforcement, defense or similar activity with respect to the Intellectual Property with the same legal force and effect as if executed by ASSIGNOR.


