**Declaration of Rebecca Givner-Forbes Regarding U.S. Serial No. 86/475,452
and Correcting Conveyance Recorded at Reel/Frame 5666/0374**

I (the undersigned), Rebecca Givner-Forbes, an associate at Cooley LLP, counsel for Sazerac North America, Inc. (“SNAI”) and Sazerac Brands, LLC (“SBL”), hereby state and declare as follows:

1. The facts stated in this declaration are based on my own personal knowledge, my review of records kept at Cooley LLP on behalf of our clients SNAI, SBL, and Sazerac Company, Inc. (“SCI”), and information provided to me by my colleagues at Cooley LLP.

2. The GLENCULLEN mark and pending U.S. trademark application for the same (U.S. Serial No. 86/475,452) were erroneously identified on the Cover Sheet and *Nunc Pro Tunc* Assignment filed on behalf of SNAI on November 11, 2015 with the Assignment Recordation Branch of the U.S. Patent and Trademark Office (PTO). This Cover Sheet and *Nunc Pro Tunc* Assignment are available at Reel/Frame 5666/0374 in the PTO’s online files.

3. SNAI had no ownership interest in the GLENCULLEN mark or U.S. Application Serial No. 86/475, 452 and therefore could not assign any interest in them.

4. **SCI**, not SNAI, had filed U.S. Application Serial No. 86/475,452, and had assigned this application and the portion of SCI’s business to which the GLENCULLEN mark pertained to **SBL**, effective January 31, 2015, under a certain Contribution Agreement between SCI and SBL (as amended July 1, 2016).

5. A Cover Sheet and *Nunc Pro Tunc* assignment reflecting the conveyance described in paragraph 4 were filed with the PTO’s Assignment Recordation Branch on July 1, 2016. These documents are available at Reel/Frame 5827/0450 in the PTO’s online files.

6. Thus, the documents at Reel/Frame 5827/0450 reflect the accurate chain of title for the GLENCULLEN mark and application.

7. The documents at Reel/Frame 5666/0374 should be removed from the chain of title for the GLENCULLEN mark and U.S. Application Serial No. 86/475,452 in order to render the PTO’s online records of such chain of title accurate.
