RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT dated as of January 25, 2017 (this "Release") is made by MIDCAP FINANCIAL TRUST, a Delaware statutory trust, acting in its capacity as administrative agent for the Lenders (in such capacity, together with its successors and assigns in such capacity, the "Administrative Agent") under that certain Trademark Security Agreement, dated as of April 11, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the "Trademark Security Agreement"), by and among FLS TRANSPORTATION SERVICES LIMITED, a British Columbia limited liability company with an address of 333 Decarie Boulevard, Suite 250, Montréal, Canada QC H4N 3M9 (the "Grantor") and Administrative Agent. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on April 11, 2016 at reel 5768, frame 0751, Grantor granted to Administrative Agent a continuing security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired Trademarks, including those set forth on the attached Schedule I (the "Trademark Collateral"); and

WHEREAS, the Obligations have been paid in full under the Credit Agreement; and

WHEREAS, Grantor has requested and Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in the Trademark Collateral and the security interest granted to Administrative Agent in the Trademark Collateral.
