FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This First Amendment to Intellectual Property Security Agreement (this "Amendment") is made as of January 24, 2017, by and between **SILICON VALLEY BANK**, a California corporation, with its principal place of business at 3003 Tasman Drive, Santa Clara, California 95054 ("Bank"), and **CENTRIFY CORPORATION**, a Delaware corporation with its chief executive office located at 3300 Tannery Way, Santa Clara, California 95054 ("Grantor").

Recitals

A. Grantor and Bank have previously entered into (a) that certain Amended and Restated Loan and Security Agreement dated as of January 29, 2016, as amended by that certain First Amendment to Amended and Restated Loan and Security Agreement dated as of August 29, 2016, and (b) that certain Subordinated Loan and Security Agreement dated as of December 30, 2014, as amended by that certain First Amendment to Loan and Security Agreement dated as of September 21, 2015, as further amended by that certain Second Amendment to Subordinated Loan and Security Agreement dated as of January 29, 2016, and as further amended by that certain Third Amendment to Subordinated Loan and Security Agreement dated as of August 29, 2016.

B. To secure its obligations and liabilities to Bank, Grantor has previously granted Bank a security interest in the Intellectual Property Collateral pursuant to that certain Intellectual Property Security Agreement dated as of January 29, 2016 (as may be amended, modified, restated, replaced, or supplemented from time to time, the "IP Security Agreement"). Capitalized terms used but not otherwise defined herein shall have the same meaning as in the IP Security Agreement.

C. Grantor and Bank have agreed to enter into this Amendment.

NOW, THEREFORE, GRANTOR AND BANK AGREE AS FOLLOWS:

A. MODIFICATION TO THE IP SECURITY AGREEMENT. Exhibits A, B, C and D to the IP Security Agreement are hereby deleted in their entirety and replaced with Exhibits A, B, C and D attached hereto.

B. RATIFICATION OF IP SECURITY AGREEMENT. Grantor hereby ratifies, confirms and reaffirms, all and singular, the terms and conditions of the IP Security Agreement, and acknowledges, confirms and agrees that the IP Security Agreement contains an accurate and complete listing of all Intellectual Property Collateral and shall remain in full force and effect.

C. COUNTERSIGNATURE. This Amendment shall become effective only when it shall have been executed by Grantor and Bank.
