RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "**Release**") is given as of January 25, 2017 by **UBS AG, STAMFORD BRANCH**, as administrative agent and as collateral agent (in such capacity, the "**Collateral Agent**") for certain secured parties pursuant to the Credit Agreement (as defined in the hereinafter defined Security Agreement), to **TEXSTAR MIDSTREAM SERVICES, LP**, a Texas limited partnership ("**TexStar**").

WHEREAS, pursuant to the Security Agreement and/or the Trademark Security Agreement, among other things, TexStar granted to the Collateral Agent a security interest in and to certain collateral including, but not limited to, the trademark and associated applications/registrations identified on **Exhibit A** to this Release, the TexStar Midstream Services logo identified on **Exhibit A** to this Release, and the domain name www.texstars.com (collectively, the "**Released Collateral**").

WHEREAS, the Collateral Agent desires to release its security interest in and liens upon the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby releases its security interest in and liens upon the Released Collateral and reassigns any and all interest it may have in the Released Collateral to TexStar.


