NOW, THEREFORE, in consideration of the mutual promises set forth in the Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors hereby confirm that they have assigned to Assignees the entire right, title and interest in and to the trademarks listed on Schedule A and Schedule B hereto, all registrations and applications for registration therefor, if applicable, the benefit of any and all past use of the trademarks, the right to recover for past, present or future infringement thereof, and the goodwill of the business connected with the use of, and symbolized by, said trademarks.




