RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Release"), is made effective as of January 13, 2017 by and from PNC BANK, NATIONAL ASSOCIATION, as administrative agent (the "Grantee"), in favor of FIRE & SECURITY HOLDINGS, LLC, a Delaware limited liability company ("Holdings"), RED HAWK FIRE & SECURITY, LLC, a Colorado limited liability company ("Red Hawk"), RED HAWK FIRE & SECURITY (NY), LLC, a New York limited liability company ("Red Hawk NY"), RED HAWK FIRE & SECURITY (CA), LLC, a California limited liability company ("Red Hawk CA"), RED HAWK FIRE & SECURITY MONITORING, LLC, a Delaware limited liability company ("RH Security"), FIRE SYSTEMS INTERNATIONAL, INC., a New York corporation ("Fire Systems"), PRATT LANDRY ASSOCIATES, INC., a Louisiana corporation ("Pratt Landry"), RED HAWK SECURITY SYSTEMS, LLC, a Texas limited liability company ("Red Hawk Systems"), CENTURY SPRINKLER HOLDINGS CORPORATION, a Delaware corporation ("Century Sprinkler"), and CHAIN ELECTRIC HOLDINGS, INC., a Delaware corporation ("Chain Electric", together with Holdings, Red Hawk, Red Hawk NY, Red Hawk CA, RH Security, Fire Systems, Pratt Landry, Red Hawk Systems and Century Sprinkler, collectively, the "Grantors", and each a "Grantor").

WHEREAS, the Grantors and the Grantee entered into that certain Trademark and Patent Security Agreement (the "Security Agreement"), dated as of April 10, 2012, pursuant to which each Grantor granted the Grantee a security interest in all of such Grantor's Trademarks (as such term is defined in the Security Agreement), including, without limitation, the Trademarks listed on Schedule 1 of the Security Agreement, and attached hereto as Schedule 1, as security for the payment and performance of certain obligations, as described in the Security Agreement;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on April 17, 2012 at Reel 4758 and Frame 0258; and

WHEREAS, the Grantee has duly authorized the execution, delivery and performance of this Release and the recording thereof;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee agrees as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release have the meanings provided in the Security Agreement.

SECTION 2. Release of Security Interest. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby releases its security interest in and continuing lien on all of the Grantors' right, title and interest in, to and under the Trademarks, including, without limitation, the Trademarks listed on Schedule 1 of the Security Agreement, and attached hereto as Schedule 1, and assigns such security interest and lien to each Grantor, as applicable. Grantee represents and warrants that: (a) it has full power and authority to execute this Release, and (b) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has in the Trademarks. Grantee hereby authorizes

each Grantor and its agents and designees to make the filings necessary to record and evidence the termination, cancellation and release of the security interests in and liens on the Trademarks.


