Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned corporation executed the following Certificate of Merger:

**FIRST:** The name of the surviving corporation is FIC Restaurants, Inc. (f/k/a Friendly's GCA, Inc.), a Massachusetts corporation ("FIC Restaurants") and the name of the limited liability company being merged into this surviving corporation is Friendly's IP, LLC, a Delaware limited liability company ("Friendly's IP" and, together with FIC Restaurants, collectively, the "Constituent Entities").

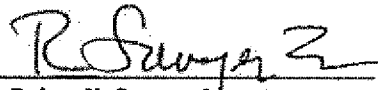
