Assignor does further consent to the recordation of this Assignment by the Assignee with the Director of the U.S. Patents and Trademark Office and covenants to take such further action and to execute, acknowledge and deliver to the Assignee, at the request of the Assignee and at Assignee's expense, such instruments and take such other actions, at any time and from time to time after the execution of this Assignment, as may be otherwise necessary to perfect the Assignee's title in and to the applicable Marks.

This Assignment shall inure to the benefit of and be binding upon the successors and assigns of Assignee and the successors and assigns of Assignor. This Assignment shall be governed by and construed in accordance with the laws of the State of Illinois, without regard to conflicts of law principles.


This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. This Assignment may be executed and delivered by facsimile or other electronic transmission.
