ASSIGNMENT OF TRADEMARK

WHEREAS, **Instinet Europe Limited**, a Private Limited Company of the United Kingdom, located and doing business at 1 Angel Lane, London EC4R 3AB, England (hereinafter referred to as "ASSIGNOR"), is the owner of the trademark and the record owner of trademark Registration No. 3,851,990 for the mark BLOCK MATCH (hereinafter referred to as the "TRADEMARK");

WHEREAS, **Instinet Holdings Incorporated**, a Delaware Corporation, located and doing business at Worldwide Plaza, 309 West 49th Street, New York, New York 10019 (hereinafter referred to as "ASSIGNEE"), did acquire all of the rights, title and interest of ASSIGNOR in, to and under the TRADEMARK, together with the portion of the goodwill of the business associated with the TRADEMARK.

NOW THEREFORE, for good and valuable consideration by it received, the said ASSIGNOR confirms that at least as early as September 28, 2010 it had sold, assigned and set over unto the said ASSIGNEE all its rights, title and interest in and to the aforesaid TRADEMARK and the registration relating thereto, together with the goodwill, with the intent that such TRADEMARK and registration shall be fully vested in the said ASSIGNEE, its successors and assigns, at least as early as September 28, 2010.

ASSIGNOR acknowledges that at least as early as September 28, 2010, ASSIGNEE became the exclusive owner of the TRADEMARK and the portion of the goodwill associated therewith; and

ASSIGNOR did also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARK, the right to sue for and collect the same for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives; and

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the TRADEMARK and title thereto as the property of the ASSIGNEE, its successors, legal representatives and assigns in accordance with the terms of this instrument.




