TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of January 23, 2017, by BANK OF THE WEST ("Secured Party").

W I T N E S S E T H:

WHEREAS, Northwest Natural Products, Inc. ("Grantor") and Secured Party were parties to that certain Trademark Security Agreement dated as of August 5, 2009 (the "Trademark Security Agreement") pursuant to which the Grantor granted a security interest to Secured Party in certain trademarks owned by Grantor as security for certain obligations owing by Grantor to Secured Party, including the trademarks set forth on **Schedule 1** hereto (collectively, the "Trademarks");

WHEREAS, a Memorandum of Security Agreement evidencing such security interest was recorded by the Trademark Division of the United States Patent and Trademark Office on June 16, 2011, at Reel 004566, Frame 0206;

WHEREAS, Grantor has requested that Secured Party release its security interest in the Trademarks and Trademark Collateral (as defined below) and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby terminates, cancels, releases and discharges its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

(a) all of its trademarks, including, without limitation, those referred to on **Schedule 1** hereto;

(b) all renewals and extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(c) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Secured Party hereby reassigns, grants and conveys to the Grantor any and all of Secured Party's right, title and interest in and to the Trademarks and the Trademark Collateral.

3. This Trademark Release and Reassignment shall be governed by and construed and interpreted in accordance with the laws of the State of New York.
