TERMINATION AND RELEASE
(Trademarks)

This TERMINATION AND RELEASE is dated as of January 31, 2017, and made by PNC BANK, NATIONAL ASSOCIATION (the “Secured Party”), in favor of HOFFMAN SOUTHWEST CORP., a corporation organized under the laws of the State of California and WESTERN DRAIN SUPPLY, INC., a corporation organized under the laws of the State of California (collectively, the “Pledgors”).

WITNESSETH:

WHEREAS, the Pledgors granted a security interest in certain Collateral (as hereinafter defined) to the Secured Party (the “Security Interest”); and

WHEREAS, the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office; and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby terminates and releases the Security Interest in the Collateral as follows:

1. Collateral. The term “Collateral,” as used herein, shall mean all of Pledgors’ right, title and interest of every kind and nature in the trademarks and service marks set forth on Schedule A attached hereto and (i) all registrations, applications, recordings and common-law rights relating thereto; (ii) all reissues, continuations, continuations-in-part or extensions thereof/ all renewals thereof; (iii) all income, license royalties, damages and payments now and hereafter due and/or receivable with respect thereto, including, without limitation, all damages and payments receivable for past, present and/or future infringements thereof; (iv) the right to sue for past, present and/or future infringements thereof; (v) all rights corresponding thereto throughout the world; and (vi) the goodwill of the Pledgors’ business connected with or symbolized by the foregoing.

2. General.

- (a) This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
- (b) All rights hereunder shall accrue to, and all obligations hereunder shall be binding upon, the heirs, representatives, successors, assigns and transferees of the parties hereto.
