PATENT AND TRADEMARK ASSIGNMENT

This Patent and Trademark Assignment (the "**Assignment**") is made and entered into as of the 25th day of November, 2015, by FNA IP Holdings, Inc., an Illinois corporation with a principal place of business at 7152 99th Street, Pleasant Prairie, Wisconsin 53158 ("**Assignor**"), and FNA Group, Inc., an Illinois corporation with a principal place of business at 7152 99th Street, Pleasant Prairie, Wisconsin 53158 ("**Assignee**") (individually, a "**Party**" and collectively, the "**Parties**").

WHEREAS, Assignor is the owner of (i) the trademarks and associated United States trademark registrations and pending trademark applications listed on Schedule A, along with (ii) the right to claim priority based on the filing date of said trademark application under the Paris Convention for the Protection of Industrial Property and all other treaties of like purposes, and (iii) all the goodwill of the business associated with the use of the Trademark Properties and symbolized thereby (the "**Trademark Properties**");

WHEREAS, Assignor is the owner of (i) all right, title and interest in and to the issued patents and patent applications identified in Schedule B appended hereto, including any and all United States and foreign patents, utility models, and design registrations granted for any inventions claimed therein or improvements thereto, including continuations, continuations-in-part and divisional applications, and (ii) the right to claim priority based on the filing date of said applications under the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention and all other treaties of like purposes (collectively, the "**Patent Properties**");

WHEREAS, Assignor is a party to certain assignable outbound license agreements related to the Patent and Trademark Properties (the "**License Agreements**") and has certain rights and obligations pursuant to the License Agreements;

WHEREAS, Assignee, as an affiliate of Assignor engaged in the conduct of the business associated with the Patent and Trademark Properties, desires to acquire all right, title and interest in and to the Patent and Trademark Properties, and to assume all rights and obligations of Assignor under the assignable License Agreements, and Assignor desires to transfer to Assignee such License Agreements and all such right, title and interest in and to the Patent and Trademark Properties;



NOW, THEREFORE, in consideration of the promises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. **Acknowledgement of Assignee Activities.** The Parties acknowledge and agree that (i) Assignee has used the Patent and Trademark Properties in the conduct of its business with the permission of and under the control of Assignor, (ii) Assignee has maintained the Assignor's quality standards and preserved the goodwill associated with the Trademark Properties; and (iii) all goodwill of the business associated with the use of the Trademark Properties generated by Assignee in the conduct of its business has inured to the benefit of Assignor.
2. **Assignment.** Assignor hereby sells, assigns, transfers and sets over to Assignee its entire right, title and interest in and to the Patent and Trademark Properties, including without limitation (1) all trademarks, pending applications for registration of trademarks, and issued registrations of trademarks related to the Trademark Properties, and the right to apply for any of the foregoing, together with the goodwill of the business associated with the use of the Trademark Properties and symbolized by the Trademark Properties; (2) all domestic and foreign patents and patent applications related to the Patent Properties, including divisions, continuations, continuations-in-

part, reexaminations, substitutions, reissues, extensions and renewals, and the right to apply for any of the foregoing; (3) all of Assignor's rights and obligations under the License Agreements, to the extent such rights and obligations are assignable; (4) all rights to causes of action and remedies related to the Patent and Trademark Properties and under the License Agreements including, without limitation, the right to sue, obtain relief and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringement of rights related to the foregoing; and (5) any and all other rights and interests arising out of, in connection with, or in relation to the Patent and Trademark Properties, the same to be held and enjoyed by Assignee, its successors, assigns and other legal representatives.

3. **Acceptance and Assumption.** Assignee hereby accepts the foregoing assignment of all rights and obligations under the License Agreements and agrees to assume, be bound by, and fully and faithfully perform and discharge each and every covenant, duty, obligation and term set forth in the License Agreements.
4. **Cooperation; Further Assistance.** Assignor shall assist Assignee, at Assignee's reasonable cost and expense (upon submission of supporting documentation), to an extent reasonably necessary to transfer title in and to the Patent and Trademark Properties or to enforce its rights in the Patent and Trademark Properties. Assignor agrees to execute, deliver, file and record, or cause to be executed, delivered, filed and recorded, such further agreements, instruments and other documents, and take, or cause to be taken, such further actions, as Assignee may reasonably request as being necessary or advisable to effect or evidence the transactions contemplated by this Assignment. To the extent notice to or consent by the individual licensees is required by the License Agreements, Assignor agrees that it shall use commercially reasonable efforts to provide such notice and obtain such consent, without which the present assignment shall not be effective as to any License Agreement requiring such notice or consent.

IN WITNESS WHEREOF, the Parties have caused this Assignment to be executed by their respective duly authorized officers, as of the Effective Date.
