1. That by written consent of the Board of Directors of the Company in Lieu of a Special Meeting pursuant to Section 141(f) of the Delaware General Corporation Law, resolutions were duly adopted by the Board of Directors of the Company setting forth a proposed amendment to the Certificate of Incorporation of the Company, declaring such amendment to be advisable and for consideration thereof by the stockholders of the Company. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Certificate of Incorporation of the Company shall be amended by striking Article I in its entirety and replacing it with a new Article I as follows:

FIRST: The name of the corporation is Precision Medicine Group, Inc.


2. That the sole stockholder of the Company representing one hundred (100%) of all the common stock of the Company executed a Written Consent of Stockholders in Lieu of a Special Meeting pursuant to Section 228 of the Delaware General Corporation Law adopting such amendment.

4. This Certificate of Amendment shall be effective as of the date of filing hereof.
