The parties intend that the Merger shall constitute a tax-free reorganization under Section 368(a) of the Internal Revenue Code of 1986, as amended, and any successor thereto, and that this Agreement shall constitute a "plan of reorganization" within the meaning of Treasury Regulation Section 1.368-2(g).


