TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is effective as of January 1, 2017, and is by and between edo Interactive, Inc., a Delaware corporation ("Assignor"), and Augeo CLO, Inc., a Delaware corporation ("Assignee"). Assignor and Assignee are collectively referred to as the "Parties".

RECITALS

NOW, THEREFORE, in consideration of the above promises and the mutual covenants contained in the Purchase Agreement and contained herein, the Parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, transfers, and assigns unto Assignee any and all right, title, and interest in and to all trademarks, common law rights, trademark registrations and applications including, but not limited to, the marks identified in Schedule A attached hereto (the "Marks"), including all rights of priority, together with any and all goodwill of the business symbolized by such Marks, the right to apply to register any of the foregoing, and all rights to causes of action and remedies relating thereto including, without limitation, the right to sue for past, present or future infringement. Assignor agrees to execute all documents, papers, forms and authorizations and take all other action that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in and to the Marks. Assignor represents and warrants that it has full power to enter into and perform this assignment, that it has not granted any person or entity any interest in the Marks.
2. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

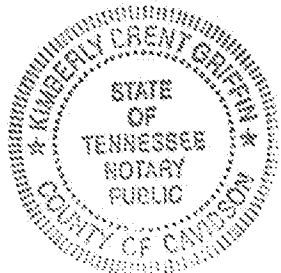


