
- KNBC – U.S. Reg. No. 1382708 (registered February 11, 1986);

WHEREAS, NATIONAL BROADCASTING COMPANY, INC., a Delaware corporation (hereinafter "Assignee"), was desirous of acquiring said mark and said registration thereof;


WHEREAS, the parties intend to confirm that, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, effective January 27, 1992, Assignor assigned unto Assignee all right, title and interest in and to said mark, together with the goodwill of the business symbolized by the mark, and the above-identified registration thereof, and all rights to damages or profits due or accrued arising out of past infringement of the said mark or injury to said goodwill, and the right to sue for and recover the same in the Assignee's own name;

WHEREAS, on May 11, 2004, the name of NATIONAL BROADCASTING COMPANY, INC. was changed to NBC UNIVERSAL, INC., and on January 28, 2011, was changed again to NBCUNIVERSAL MEDIA, LLC.
