1. The name of the limited liability company shall be Stelligent Systems LLC.

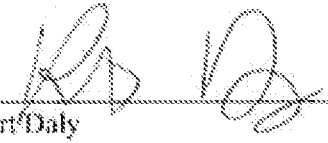

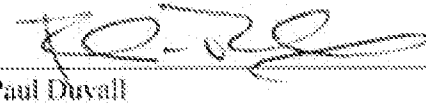
