CERTIFICATE OF MERGER

(the "Merged Corporation")

INTO

LEACHGARNER, INC., a Delaware corporation
(the "Surviving Corporation")

Pursuant to Title 8, Section 252 of the Delaware General Corporation Law and Section 13.1-719 of the Virginia Stock Corporation Act, the undersigned corporations executed the following Certificate of Merger:

FIRST: The name of the Surviving Corporation is LeachGarner, Inc., a Delaware corporation, and the name of the Merged Corporation is John C. Nordt Co., Inc., a Virginia corporation.

SECOND: The Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8, Section 252 of the General Corporation Law of the State of Delaware and pursuant to Section 13.1-719 of the Virginia Stock Corporation Act.

THIRD: The name of the Surviving Corporation is LeachGarner, Inc., a Delaware corporation.

FOURTH: The Certificate of Incorporation of the Surviving Corporation shall continue to be its Certificate of Incorporation.

FIFTH: The authorized stock of the Merged Corporation is Five Thousand (5,000) shares of common stock.

SIXTH: The merger is to become effective on June 1, 2016 at 12:01 a.m. Eastern Daylight Time.

SEVENTH: The Agreement of Merger is on file at the offices of the Surviving Corporation at 49 Pearl Street, Attleboro, MA 02703.

EIGHTH: A copy of the Agreement of Merger will be furnished by the Surviving Corporation on request, without cost, to any stockholder of the constituent corporations.
