See Jane Farm, Inc., a corporation organized and existing under the laws of the State of Delaware (the "*Corporation*"), certifies that:

FIRST: The name of the Corporation is See Jane Farm, Inc. The Corporation's original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on August 21, 2014.

SECOND: That the Board of Directors of the Corporation, acting in accordance with Section 242 of the General Corporation Law of the State of Delaware, adopted resolutions setting forth the proposed amendment of the Certificate of Incorporation of the Corporation, declaring said amendment to be advisable, and authorizing the appropriate officers of the Corporation to solicit the written consent of the stockholders of the Corporation upon the consideration thereof.

THIRD: That thereafter, pursuant to a resolution of the Corporation's Board of Directors, the written consent of the stockholders of the Corporation was duly called for in accordance with Section 228(a) of the General Corporation Law of the State of Delaware, and the holders of the requisite number of shares as required by statute consented to the adoption of said amendment.

FOURTH: That Article I of the Certificate of Incorporation of the Corporation is amended to read in its entirety as follows:

"ARTICLE I

The name of the corporation is Plenty United Inc."
