RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of this 3rd day of February, 2017, by JPMorgan Chase Bank, N.A., as administrative agent (in such capacity, "Agent") under the Amended and Restated Revolving Facility Credit Agreement dated May 14, 2013 by and among Fender Musical Instruments Corporation, the lenders party thereto and Agent, in favor of ROKR Ventures, Inc., a Delaware corporation ("ROKR"), ROKR Distribution US, Inc., a Connecticut corporation (formerly known as KMC Music, Inc.) ("KMC"), Fender Musical Instruments Corporation, a Delaware corporation ("FMIC"), and Jackson/Charvel Manufacturing, Inc., a Delaware corporation ("JCM") (collectively, jointly and severally, the "Grantors").

Reference is made to that certain Payoff Letter dated as of February 3, 2017 between, inter alia, Administrative Agent and the Grantors (the "Payoff Letter").

All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or, if not defined in the Security Agreement, in the applicable Trademark Security Agreement. For the purpose of the Release, (i) "Security Agreement" means the Guarantee and Collateral Agreement, dated as of June 7, 2007, by and among Fender Musical Instruments Corporation, Fender Asia Pacific Corp., Fender International Corporation, Jackson/Charvel Manufacturing, Inc., KMC Music, Inc., KMI Europe, Inc., and ROKR Ventures, Inc., as grantors, and Agent, as amended, restated, supplemented or otherwise modified; and (ii) "Trademark Security Agreements" mean the (A) Grant of Security Interest in Trademark Rights, dated as of May 16, 2013, between ROKR and Agent, (B) Grant of Security Interest in Trademark Rights, dated as of May 16, 2013, between KMC and Agent, (C) Amended and Restated Grant of Security Interest in Trademark Rights, dated as of May 16, 2013, between

FMIC and Agent, and (D) Amended and Restated Grant of Security Interest in Trademark Rights, dated as of May 16, 2013, between JCM and Agent , in each case, as amended, restated, supplemented or otherwise modified.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Payoff Letter, Agent hereby releases, relinquishes and discharges all of its liens on and security interests in, to and under the Trademarks constituting Collateral, including, but not limited to, those trademarks listed on Schedule 1 attached hereto and made a part hereof, and re-assigns to the Grantors any and all right, title or interest it may have in such Trademarks constituting Collateral (including, but not limited to, those trademarks listed on Schedule 1), which liens and security interests were established under and pursuant to the Security Agreement and the Trademark Security Agreements recorded with the United States Patent and Trademark Office.

The Agent hereby authorizes any Grantor, or any authorized representatives of the Grantors, to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to any conflict of law principles thereof.
