**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "*Release*"), dated as of February 8, 2017, is made by Bank of America, National Association, successor to LaSalle Bank National Association (the "*Secured Party*").

WHEREAS, Harmon Solutions Group, LLC, a Delaware limited liability company ("*Borrower*"), granted LaSalle Bank National Association a security interest (the "*Security Interest*") in certain United States trademarks identified on Schedule A hereto (the "*Trademarks*") under a Security Agreement, dated as of February 28, 2007, by and between the Borrower and LaSalle Bank National Association (the "*Security Agreement*");

WHEREAS, the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office at Reel/Frame 3498/0001;

WHEREAS, the Secured Party acquired LaSalle Bank National Association subsequent to the execution of the Security Agreement;

WHEREAS, the title, rights and interests in the SMARTECH trademark (Registration No. 3,061,889) was assigned to Synergistic International LLC, a Texas limited liability company ("*Synergistic*") (recorded at Reel/Frame 4418/0434);

WHEREAS, the title, rights and interests in the PROCLAIM trademark (Registration No. 2,157,407) was assigned to Harmon Autoglass Intellectual Property, LLC, a Delaware limited liability company ("*HAIP*") (recorded at Reel/Frame 3448/0188);

WHEREAS, the title, rights and interest in the Trademarks are held by the Borrower, HAIP and/or Synergistic (collectively the "*Owners*"), as noted on Schedule A;

WHEREAS, Borrower requests that the Secured Party terminate and release the entirety of its Security Interest in the Trademarks; and

WHEREAS, the Secured Party grants such request.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Secured Party hereby agrees as follows:

1. Release. The Secured Party hereby terminates and releases the Security Interest in the Trademarks and hereby transfers and assigns to Owners any and all of its right, title and interest in and to the Trademarks, as noted on Schedule A.

2. Further Assurance. At the request of any Owner, the Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

3. Recordation. The Secured Party hereby authorizes and requests that the Commissioner of Patent and Trademarks and any other applicable United States government officer record this Release.

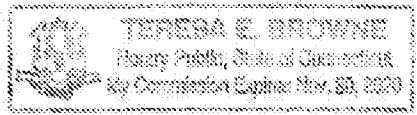
