**RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**, dated as of February 1, 2017 (this "Release"), is made by **JPMORGAN CHASE BANK, N.A.** (the "Assignor"), in its capacity as administrative agent under that certain Credit Agreement dated as of December 27, 2013 (as amended by Amendment No. 1 to the Credit Agreement, dated as of June 24, 2015 and Amendment No. 2 to the Credit Agreement, dated as of January 27, 2017, and as may be further amended, amended and restated, extended, supplemented or otherwise modified from time to time, the "Credit Agreement"), in favor of the parties set forth on Schedule 1 hereto (the "Assignees"). Capitalized terms used but not defined herein shall have the meanings set forth in the Credit Agreement.

**WITNESSETH:**

**WHEREAS**, the Assignor and the Assignees are parties to (i) that certain Security Agreement, dated as of December 27, 2013 (as amended, amended and restated, extended, supplemented or otherwise modified from time to time, the "Security Agreement"), and (ii) that certain Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of December 27, 2013, (iii) that certain Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of March 14, 2014, (iv) that certain Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of October 24, 2014, and (v) that certain Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of August 13, 2015, (the "Trademark Security Agreements");

**WHEREAS**, pursuant to the Trademark Security Agreements, the Assignees pledged and granted to the Assignor a continuing security interest in and Lien on the Assignees' right, title and interest in and to the items set forth on Schedule 2 hereto (collectively, the "Trademark Collateral");

**WHEREAS**, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office ("USPTO") as follows: in respect of Tribune Media Services, LLC on January 23, 2014 on Reel 5199, Frame 0400; in respect of Gracenote, Inc. on March 19, 2014, on Reel 5240, Frame 0233; in respect of Baseline Acquisitions LLC on October 28, 2014 on Reel 5388, Frame 0941; in respect of Gracenote, Inc. on August 14, 2015 on Reel 5599, Frame 0506; and

**WHEREAS**, the Assignees desire that the Assignor terminate and release its continuing security interest in and Lien on the Assignees' right, title and interest in and to the Trademark Collateral.

**NOW THEREFORE**, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

SECTION 1. *Release of Security Interest in Trademark Collateral.* The Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its continuing security interest in and Lien on the Assignees' right, title and interest in and to the Trademark Collateral, and reassigns and transfers to the Assignees all right, title and interest that the Assignor may have in the Trademark Collateral.


