ARTICLES OF CONVERSION  
of  
HEALTHRISK RESOURCE GROUP, LLC

HealthRisk Resource Group, LLC, an Iowa limited liability company (the "Company"), shall be converted to an Iowa corporation on the following terms:

**FIRST:** The name of the Iowa Company is HealthRisk Resource Group, LLC. Its original Articles of Incorporation were filed with the Iowa Secretary of State on March 10, 1998. The entity subsequently filed Articles of Organization on September 27, 2006, to form the current Iowa Company, HealthRisk Resource Group, LLC.

**SECOND:** The name of the entity to which the Company will be converted is HealthRisk Resource Group, Inc. (the "Corporation"). The place of incorporation is the State of Iowa.


**THIRD:** The conversion, including these Articles of Conversion and the Articles of Incorporation, has been approved by the Company in accordance with Chapter 489.1008 of the Annotated Code of Iowa and in accordance with the Company's governing documents.


**FOURTH:** The effective time of the conversion shall be the date on which these Articles are accepted for record.

**FIFTH:** All of the membership interest of the Company issued to the sole member of the Company shall, for all purposes, be deemed to be one hundred (100) shares of common stock of the Corporation, consisting of all of the issued and outstanding common stock of the Corporation, such stock to be converted without further act to stock of the Corporation.

**SIXTH:** The undersigned Chief Executive Officer of the Company acknowledges these Articles of Conversion to be the act of the Company, and further, as to all matters or facts required to be verified under oath, the undersigned officer acknowledges that to the best of his knowledge, information and belief, these matters and facts relating to the Company are true in all material respects and that this statement is made under the penalties of perjury.
