**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of this 3rd day of February, 2017, by JPMorgan Chase Bank, N.A., as administrative agent (in such capacity, "Agent") under the Term Facility Credit Agreement, dated April 3, 2013, by and among Fender Musical Instruments Corporation, the several lenders from time to time parties thereto and Agent, in favor of ROKR Ventures, Inc., a Delaware corporation ("ROKR"), ROKR Distribution US, Inc. (f/k/a KMC Music, Inc.), a Connecticut corporation ("KMC"), Fender Musical Instruments Corporation, a Delaware corporation ("FMIC"), and Jackson/Charvel Manufacturing, Inc., a Delaware corporation ("JCM") (collectively, jointly and severally, the "Grantors").

Reference is made to that certain Payoff Letter, dated as of February 3, 2017, between, inter alia, Administrative Agent and the Grantors (the "Payoff Letter").

For the purpose of the Release, (i) "Security Agreement" means the Term Facility Guarantee and Collateral Agreement, dated as of April 3, 2013, by and among FMIC, Fender Asia Pacific Corp., Fender International Corporation, JCM, KMI Europe, Inc., KMC, and ROKR, as grantors, and Agent (as amended, supplemented or otherwise modified from time to time); and (ii) "Trademark Security Agreements" mean the following (as amended, supplemented or otherwise modified from time to time):

- 1) Grant of Security Interest in Trademark Rights, dated as of April 3, 2013, between FMIC and Agent, recorded with the United States Patent and Trademark Office ("PTO") on May 17, 2013, at Reel 5074, Frame 0967;
- 2) Grant of Security Interest in Trademark Rights, dated as of April 3, 2013, between JCM and Agent, recorded with the PTO on May 17, 2013, at Reel 5030, Frame 0821;

- 3) Grant of Security Interest in Trademark Rights, dated as of April 3, 2013, between KMC and Agent, recorded with the PTO on May 17, 2013, at Reel 5029, Frame 0381;
- 4) Grant of Security Interest in Trademark Rights, dated as of May 16, 2013, between ROKR and Agent, recorded with the PTO on May 17, 2013, at Reel 5030, Frame 0863;
- 5) Supplement No. 1 to the Grant of Security Interest in Trademark Rights, dated as of October 2, 2014, between FMIC and Agent, recorded with the PTO on October 14, 2014, at Reel 5380, Frame 0653; and
- 6) Supplement No. 1 to the Grant of Security Interest in Trademark Rights, dated as of October 2, 2014, between KMC and Agent, recorded with the PTO on October 14, 2014, at Reel 5380, Frame 0666.

All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or, if not defined in the Security Agreement, in the applicable Trademark Security Agreement.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Payoff Letter, Agent hereby releases, relinquishes and discharges all of its liens on and security interests in, to and under the Trademarks constituting Collateral, including, but not limited to, those trademarks listed on Schedule 1 attached hereto and made a part hereof, and re-assigns to the Grantors any and all right, title or interest it may have in such Trademarks constituting Collateral (including, but not limited to, those trademarks listed on Schedule 1), which liens and security interests were established under and pursuant to the Security Agreement and the Trademark Security Agreements recorded with the PTO.


The Agent hereby authorizes any Grantor, or any authorized representatives of the Grantors, to record this Release with the PTO and/or any other applicable governmental office or agency.
