WHEREAS, the Assignors have entered into that certain Guarantee and Collateral Agreement, dated as of June 26, 2014, with the Assignee (as amended, supplemented or otherwise modified prior to the date hereof, the "Guarantee and Collateral Agreement");

WHEREAS, in accordance with the Guarantee and Collateral Agreement, the Assignors have entered into that certain Trademark Security Agreement dated as of June 26, 2014 that was recorded at Reel/Frame 005318/0761 (the "Trademark Security Agreement");

WHEREAS, in accordance with the Guarantee and Collateral Agreement and that certain Amendment and Restatement Agreement dated as of October 22, 2015, between the Assignors and the Assignee, among others, the Assignors have entered into that certain Amended and Restated Trademark Security Agreement, dated as of October 22, 2015 with Assignee (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "A&R Trademark Security Agreement"), pursuant to which the Assignors granted to Assignee, for the benefit of the Secured Parties (as defined in the Guarantee and Collateral Agreement), a continuing security interest in and to all of the Assignors' right, title and interest in, to and under its trademarks including all of the Assignors' right, title and interest in and to the trademark registrations listed on the attached Schedule A (the "Trademarks") together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Obligations (as defined in the Guarantee and Collateral Agreement);

WHEREAS, the Assignee has recorded with the United States Patent and Trademark Office (the "USPTO") the A&R Trademark Security Agreement, at Reel/Frame 005651/0175 providing notice of the Assignee's security interest in the Trademarks and Collateral; and

WHEREAS, the Assignors have paid all outstanding amounts currently owing under the Guarantee and Collateral Agreement and the other financing documents executed in connection therewith and has requested that Assignee release its security interest in the Trademarks and Collateral owned by the Assignors.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the Assignee hereby irrevocably and forever terminates, releases and discharges any and all security interests and any other rights, title and interest it has in, to and under in the Trademark and Collateral granted by the Assignors under the Guarantee and Collateral Agreement, the Trademark Security Agreement and the A&R Trademark Security Agreement.

2. Recordation of Release. The Assignee understands and agrees that this Release may be recorded by or for the Assignors (or its assignee) with the USPTO.

3. Further Actions. At the written request of the Assignors following the termination of the Guarantee and Collateral Agreement, at the Assignors' sole cost and expense, the Assignee shall execute and deliver to the Assignors (or its assignees) such documents as the Assignors shall reasonably request to evidence the termination.

4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Guarantee and Collateral Agreement and/or the A&R Trademark Security Agreement, as applicable.
