Trademark and Domain Name Assignment Agreement

This Trademark and Domain Name Assignment Agreement (the "**Agreement**") is made as of December 20, 2016 (the "**Effective Date**") by and between Cannery Casino Resorts, LLC ("**Assignor**"), a Nevada limited liability company, and Boyd Gaming Corporation ("**Assignee**"), a Nevada corporation (referred to collectively as the "**Parties**" and individually as a "**Party**").

WHEREAS, in accordance with and subject to that certain Membership Interest Purchase Agreement dated April 25, 2016 by and between Assignor, Assignee and certain other parties ("**Purchase Agreement**"), Assignor wishes to assign all right, title and interest in and to the trademarks and domain names set forth in Exhibit A, and all goodwill associated with the foregoing, together with any and all registrations and applications for registration thereof (collectively, the "**Marks**") to Assignee, and Assignee wishes to accept such assignment;

NOW, THEREFORE, in consideration of the mutual agreements, provisions and covenants contained herein, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignment.

Assignor hereby irrevocably and perpetually transfers, conveys and assigns to Assignee all Assignor's right, title and interest throughout the world in and to the Marks, together with (a) all national, foreign and state registrations, registrations with applicable domain name registrars, applications for registration and renewals and extensions thereof, (b) Assignor's rights and interest in the registration agreements pursuant to which the domain names were registered, (c) all common law rights related thereto, (d) all goodwill associated therewith, and (e) and all benefits, privileges, causes of action and remedies relating to any of the foregoing, whether before or hereafter accrued (including, without limitation, the exclusive rights to apply for and maintain all such registrations, renewals and/or extensions; to sue for all past, present or future infringements or other violations of any rights in the Marks; and to settle and retain proceeds from any such actions) (collectively, the "**Rights**"). Assignor retains no rights to use the Marks and agrees not to challenge the validity of Assignee's ownership in the Marks.

2. Cooperation.

Assignor shall take all necessary steps to transfer the domain names to Assignee. Without limitation of the preceding sentence, Assignor shall cooperate with and assist Assignee in completing any electronic transfer of the domain name initiated by Assignor, including by giving all necessary consents and instructions to the applicable domain name registrars. In addition, Assignor shall execute such written instruments, extend such other cooperation and perform such other acts as may be necessary or appropriate, in the opinion of Assignee, to convey, establish, evidence, maintain, defend and enforce Assignee's Rights in the Marks. If Assignor is unwilling or unable to execute any such written instruments or perform such other acts, Assignor hereby appoints Assignee and its designees as Assignor's attorney-in-fact to execute such documents on Assignor's behalf. The foregoing appointment shall be deemed a power coupled with an interest and is therefore irrevocable.

3. Miscellaneous.

This Agreement is made under and shall be construed in accordance with the laws of the State of New York, without giving effect to any choice of law rule that would cause the application of the laws of any jurisdiction other than the internal laws of the State of New York to the rights and duties of the Parties. The Parties hereto shall not be considered as joint venturers, partners, employers or agents of each other, and neither shall have the power to bind or obligate the other except as set forth in this Agreement. This Agreement may be executed in two (2) or more copies, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. If any provision or provisions of this Agreement are held to be invalid, illegal or unenforceable, in whole or in part, under any law or regulation, by a court of competent jurisdiction, then such provision or portion of such provision, as appropriate, shall remain in effect only to the extent that it is valid, and the validity, legality and enforceability of the remaining provisions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated thereby. This Agreement and the Purchase Agreement constitutes the entire agreement between the Parties relating to the subject matter hereof and supersedes all prior agreements, understandings and representations concerning such subject matter. No amendment or modification to any of the terms hereof shall be valid or binding upon the Parties unless made in writing and signed by duly authorized representatives of the Parties.


