**CERTIFICATE OF AMENDMENT OF SIXTH AMENDED AND RESTATED  
CERTIFICATE OF INCORPORATION  
OF STRONGVIEW SYSTEMS, INC.**

StrongView Systems, Inc. (the "Corporation"), a corporation organized and existing under the General Corporation Law of the State of Delaware, hereby certifies as follows:

1. This Certificate of Amendment (the "Certificate of Amendment") amends the provisions of the Corporation's Sixth Amended and Restated Certificate of Incorporation attached as Annex A to that certain Certificate of Merger of SV Acquisition Corp., a Delaware corporation, with and into the Corporation filed with the Delaware Secretary of State on September 23, 2015 (the "Certificate of Incorporation").

2. Article First of the Certificate of Incorporation is hereby amended and restated in its entirety as follows:

"FIRST. The name of the Corporation is Selligent, Inc. (the "Corporation")."

3. This amendment was duly adopted in accordance with the provisions of Sections 242 and 228 (by the written consent of the stockholders of the Corporation) of the General Corporation Law of the State of Delaware.

4. All other provisions of the Certificate of Incorporation shall remain in full force and effect.
