ASSIGNMENT

STONE**, its successors, assigns and legal representatives, **LA PIETRA'S** entire right, title and interest in and to said Trademark Rights, together with the goodwill of the business symbolized by said Trademark Rights and all rights of action against past infringement thereof, the same to be held and enjoyed by said **R. STONE**, its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by said **LA PIETRA** if this Assignment and sale had not been made.

LA PIETRA agrees to execute or procure the execution of any and all future Assignments, or other instruments which may be necessary to perfect and evidence ownership of the property and

rights herein assigned to R. STONE.
