**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 10, 2017 (“Release”), is made by Bank of America, N.A. (“Secured Party”) in favor of Tanimura & Antle Fresh Foods, Inc., a California corporation (“Grantor”).

WHEREAS, pursuant to that certain Security Agreement dated as of December 1, 2008 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Grantor and Secured Party Grantor granted to the Secured Party a security interest in and to all of the Grantor’s right, title and interest in and to trademark registration and applications therefore, together with the goodwill and assets of the business and all actions for infringement concerning the foregoing (collectively, “Trademark Collateral”); and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Memo.

SECTION 2. Termination and Release. Secured Party, without representation, warranty, or recourse, hereby:


(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to all of the Grantor’s right, title and interest in and to Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Memo; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.
