**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of February 10, 2017, by WELLS FARGO BANK, NATIONAL ASSOCIATION (“Wells Fargo”), in connection with the Credit and Security Agreement, dated as of November 2, 2015 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), by and among WOOD-MODE, INCORPORATED, a Pennsylvania corporation (“Borrower”), MIDTOWN KITCHEN CABINETS, LLC, a New York limited liability company (“Guarantor”) and Wells Fargo. Capitalized terms used but not defined herein shall have the meanings given to such terms in the Security Agreement referenced below.

WHEREAS, Borrower previously executed and delivered in favor of Wells Fargo that certain Intellectual Property Security Agreement, dated as of November 2, 2015 (the “Security Agreement”), which Security Agreement was recorded with the United States Patent and Trademark Office at Reel 036941, Frame 0083 and Reel 5658, Frame, 0908 on November 2, 2015, and was submitted for filing with the United States Copyright Office on November 25, 2015, for the purpose of securing payment and performance of the Obligations;

WHEREAS, pursuant to the Security Agreement, Borrower granted, assigned and pledged to Wells Fargo, as collateral security for the Obligations, all of the Patents, Copyrights and Trademarks listed on Exhibits A, B and D thereto;

WHEREAS, Wells Fargo has agreed to release, and terminate its security interest in, the Patents, Copyrights and Trademarks and assign and transfer to Borrower all deeds, assignments and other instruments as may be necessary or proper to reassign and reconvey to Borrower the entire right, title and interest to the Patents, Copyrights and Trademarks as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Wells Fargo hereby releases and terminates the Security Agreement and assign and transfers to Borrower, without representation, warranty or recourse, all of Wells Fargo’s right, title and interest in and to the Patents, Copyrights and Trademarks (including, without limitation, the Patents, Copyrights and Trademarks set forth on Exhibits A, B and C hereto), effective as of the date set forth above.
