## RELEASE OF SECURITY INTEREST IN TRADEMARKS

February 10, 2017

WHEREAS, Harmless Harvest, Inc., a Delaware corporation (the "Borrower"), is a party to a Patent and Trademark Security Agreement, dated November 25, 2015 (the "Patent and Trademark Security Agreement") by and among Borrower and Wells Fargo Bank, National Association ("Lender");

WHEREAS, Borrower granted a security interest in certain trademarks to Lender;

WHEREAS, an executed copy of the Patent and Trademark Security Agreement was recorded in the United States Patent and Trademark Office on January 5, 2016 at Reel 005702, Frame 0768; and

WHEREAS, in connection with the termination of the Patent and Trademark Security Agreement, Borrower has requested that Lender release and reassign its interest in the trademarks and trademark applications identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby:

1. releases and reassigns to Borrower any and all liens, security interests, right, title and interest of Lender, pursuant to the Patent and Trademark Security Agreement, in the trademarks, trademark registrations, and trademark applications identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby;
2. agrees that any power of attorney or similar rights granted by Borrower to Lender pursuant to or in connection with the Patent and Trademark Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given and any other filings necessary to evidence the release and termination of Lender's rights under the Patent and Trademark Security Agreement.

The validity, interpretation and enforcement of this Release of Security Interest in Trademarks shall be governed by the laws of the State of California but excluding any principles of conflicts of law or other rule of law that would cause the application of the law of any jurisdiction other than the laws of the State of California.
