TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made and entered into by and between Georgia-Pacific Wood Products LLC, a Delaware limited liability company ("Assignor"), and Georgia-Pacific Consumer Products LP, a Delaware limited partnership ("Assignee").

WHEREAS, Assignor is the sole and exclusive owner of the entire right, title and interest in and to the trademarks set forth on Schedule A ("Marks"), and the goodwill associated therewith; and

WHEREAS, Assignor wishes to assign to Assignee all right, title and interest in and to the Marks, together with the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee, each intending to be legally bound, hereby agree as follows:

1. Assignor does hereby sell, assign, transfer and set over to Assignee the Assignor's entire right, title and interest in and to the Marks together with the Assignor's goodwill in connection with which the Marks are used, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment had not been made, together with all income, royalties or payments in respect of the Marks due or payable as of the date hereof or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.


2. Assignee shall request the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office to record Assignee as owner of the Marks for the sole use and enjoyment of assignee, its successors, assigns or other legal representatives. The United States application is being assigned as part of the entire business or portion thereof to which the mark pertains, as required by Section 10 of the Trademark Act, 15 U.S.C. § 1060. Assignee shall request the individual or agency responsible for trademarks in the countries outside of the United States referenced in Schedule A, to record Assignee as owner of the Marks, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.


