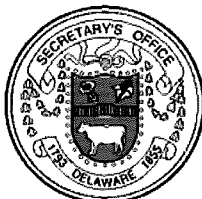

Sapient Corporation, a corporation incorporated on the 18<sup>th</sup> day of September, 1991, pursuant to the provisions of the General Corporation Law of the State of Delaware, does hereby certify that:

**FIRST:** This corporation owns 100% of the capital stock of Second Story, Inc., a corporation incorporated on the 3<sup>rd</sup> day of December, 1998, pursuant to the provisions of the Business Corporation Act of the State of Oregon; and this corporation, by resolution of its Board of Directors adopted by unanimous written consent dated the 8<sup>th</sup> day of December, 2016, determined to and did merge into itself said Second Story, Inc., which resolutions are set forth below. References in the resolutions have the following meaning: "Company" refers to Sapient Corporation; "Story" refers to Second Story, Inc.; and "Merger" refers to merging Second Story, Inc. with and into Sapient Corporation in a parent/subsidiary merger pursuant to Section 253 of the General Corporation Law.

**RESOLVED,** that the Merger is deemed advisable in the judgment of the undersigned, in order that the Company may assume any and all of the property, assets, rights, powers, and privileges of Story, and may be liable for any and all of the debts and obligations of Story, in accordance with the terms of a Plan of Merger.


**RESOLVED,** that the duly elected officers of the Company and persons designated by them are hereby authorized and directed by the undersigned to sign a Certificate of Ownership for purposes of carrying out the Merger pursuant to Section 253 of the Delaware General Corporation Law; cause it to be filed with the Delaware Secretary of State and recorded in the county of New Castle; cause it to be filed and recorded in all other jurisdictions where the Company and/or Story is registered to do business; and take any and all further actions, and sign and cause to be filed any and all further documents, necessary to effect and record the Merger.

**SECOND:** Anything herein or elsewhere to the contrary notwithstanding, this merger may be amended or terminated and abandoned by the Board of Directors of Sapient Corporation at any time prior to the time that this merger filed with the Secretary of State becomes effective.

**THIRD:** The merger and this Certificate of Ownership shall be effective upon filing.
