ASSIGNMENT OF TRADEMARK

THIS AGREEMENT is entered into with an effective date of January 10, 2017, by and between Warm Springs Productions, LLC, a Montana limited liability company with offices at 820 West Spruce, Missoula MT 59802 ("WSP") and Scripps Networks, LLC, a limited liability company formed under the laws of Delaware, with offices at 9721 Sherrill Blvd., Knoxville TN 37932 ("SN").


WHEREAS, WSP is the owner of the trademark MOUNTAIN LIFE for "Entertainment in the nature of ongoing television programs in the field of documentaries; entertainment services in the nature of an ongoing reality based television program; entertainment, namely, production of television shows" (the "Trademark"), in Class 41, which Trademark is also the subject of U.S. Trademark Reg. No. 4,994,872 (the "Registration");

WHEREAS, WSP has agreed to transfer all right, title and interest in the Trademark along with all associated goodwill, and the Registration, to SN; and

WHEREAS, SN desires to acquire all right, title and interest in and to the Trademark, its goodwill and the Registration.

NOW, THEREFORE, for good consideration, the receipt of which is hereby acknowledged by the parties, WSP hereby assigns, and transfers to SN its successors and assigns the full and entire right, title, and interest in and to the Trademark and the Registration, and all goodwill associated therewith, and the right to sue for and recover damages for past infringements of the Trademark and the Registration and to stand in the place of WSP in all matters related thereto.
