RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) made as of January 17, 2017, is granted by ROYAL BANK OF CANADA, in its capacity as collateral agent (the “Collateral Agent”) pursuant to that certain Notice of Assignment of Trademark Security, dated November 12, 2013 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “Notice of Assignment”), in favor of MEDIA GENERAL COMMUNICATIONS HOLDINGS, LLC, a Delaware limited liability company (the “Grantor”). Capitalized terms used herein have the meaning attributed thereto in the Notice of Assignment.

WHEREAS, the Grantor and Bank of America, N.A. (the “Original Collateral Agent”) entered into those certain Trademark Security Agreements dated as of December 19, 2008 (the “Trademark Security Agreements”), whereby Grantor granted to the Original Collateral Agent a continuing security interest in all of its right, title and interest in the Trademark Collateral (as defined in the Trademark Security Agreements), including, without limitation, each trademark registration and application listed on Schedule I attached hereto and incorporated herein by reference (the “Released Trademarks”);

WHEREAS, the Trademark Security Agreements were recorded in the records of the U.S. Patent and Trademark Office: (a) on January 5, 2009 at Reel 003912, Frame 0950 and (b) on January 12, 2009 at Reel 003916, Frame 0704;

WHEREAS, the Original Collateral Agent resigned as Collateral Agent under the Trademark Security Agreements, and the Original Collateral Agent, Wells Fargo Bank, N.A. (the “Second Collateral Agent”) and Grantor entered into that certain Notice of Assignment of Trademark Security Agreement dated as of June 19, 2012 (the “First Assignment”);

WHEREAS, the First Assignment was recorded in the U.S. Patent and Trademark Office on June 25, 2012 at Reel 4807, Frame 0344;

WHEREAS, the Second Collateral Agent resigned as Collateral Agent under the Trademark Security Agreements;

WHEREAS, the Collateral Agent was appointed as successor Collateral Agent under the Trademark Security Agreements and succeeded to all rights, duties, authority and responsibilities of the Collateral Agent thereunder pursuant to (i) that certain Instrument of Succession, dated as of November 12, 2013 and (ii) the Notice of Assignment;

WHEREAS, the Notice of Assignment was recorded in the U.S. Patent and Trademark Office on November 12, 2013 at Reel 5152, Frame 0910; and

WHEREAS, the Grantor has requested and the Collateral Agent has agreed to release, discharge, relinquish, terminate and dissolve its security interest in and continuing lien on all of Grantor's right, title and interest in, to and under the Released Trademarks.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Released Trademarks pursuant to the Trademark Security Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby, on behalf of itself and the Creditors, states and agrees as follows:

1. Release of Security Interest. The Collateral Agent hereby terminates the Trademark Security Agreements and terminates, releases and discharges its and the Creditors' security interests in the Released Trademarks, and any right, title or interest of the Collateral Agent or any Creditor in such Released Trademarks shall hereby cease and become void.

2. Further Assurances. The Collateral Agent agrees to execute and deliver to Grantor any and all further documents and instruments, and do any and all further acts which Grantor (or its agents or designees) reasonably requests (at Grantor's sole cost and expense) in order to confirm this Release.


