## RELEASE OF SECURITY INTEREST IN TRADEMARK

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK (this "*Release*") is made this 11<sup>th</sup> day of February, 2017 by Wells Fargo Bank, National Association, a national banking association, as Administrative Agent (the "*Administrative Agent*").

WHEREAS, reference is made to that certain Trademark Security Agreement, dated as of December 19, 2012 (the "*Trademark Security Agreement*"), by and between Supreme Indiana Operations, Inc., a Delaware corporation (the "*Grantor*"), and the Administrative Agent, which was recorded with the United States Patent and Trademark Office on December 20, 2012 in the trademark assignment records under reel/frame number 4926/0506; all capitalized terms used herein but not otherwise defined herein shall have the meanings assigned thereto in the Trademark Security Agreement or the Credit Agreement or Collateral Agreement identified therein; and

WHEREAS, pursuant to the Trademark Security Agreement, Grantor granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in, among other things, all of the right, title and interest of the Grantor in and to the Trademarks and Trademark Licenses identified therein, including but not limited to the Trademark identified on Schedule A attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby irrevocably and forever releases and terminates its security interest in and to the Trademark identified on Schedule A hereto; provided that this Release shall not affect or operate to release the security interest of the Administrative Agent in respect of any of the other Trademarks and/or Trademark Licenses described in the Trademark Security Agreement. Further, the Administrative Agent understands

and agrees that this Release may be recorded by or for the Grantor with the United States Patent and Trademark Office and any other similar office or agency throughout the world. The Administrative Agent also agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release.


This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
